



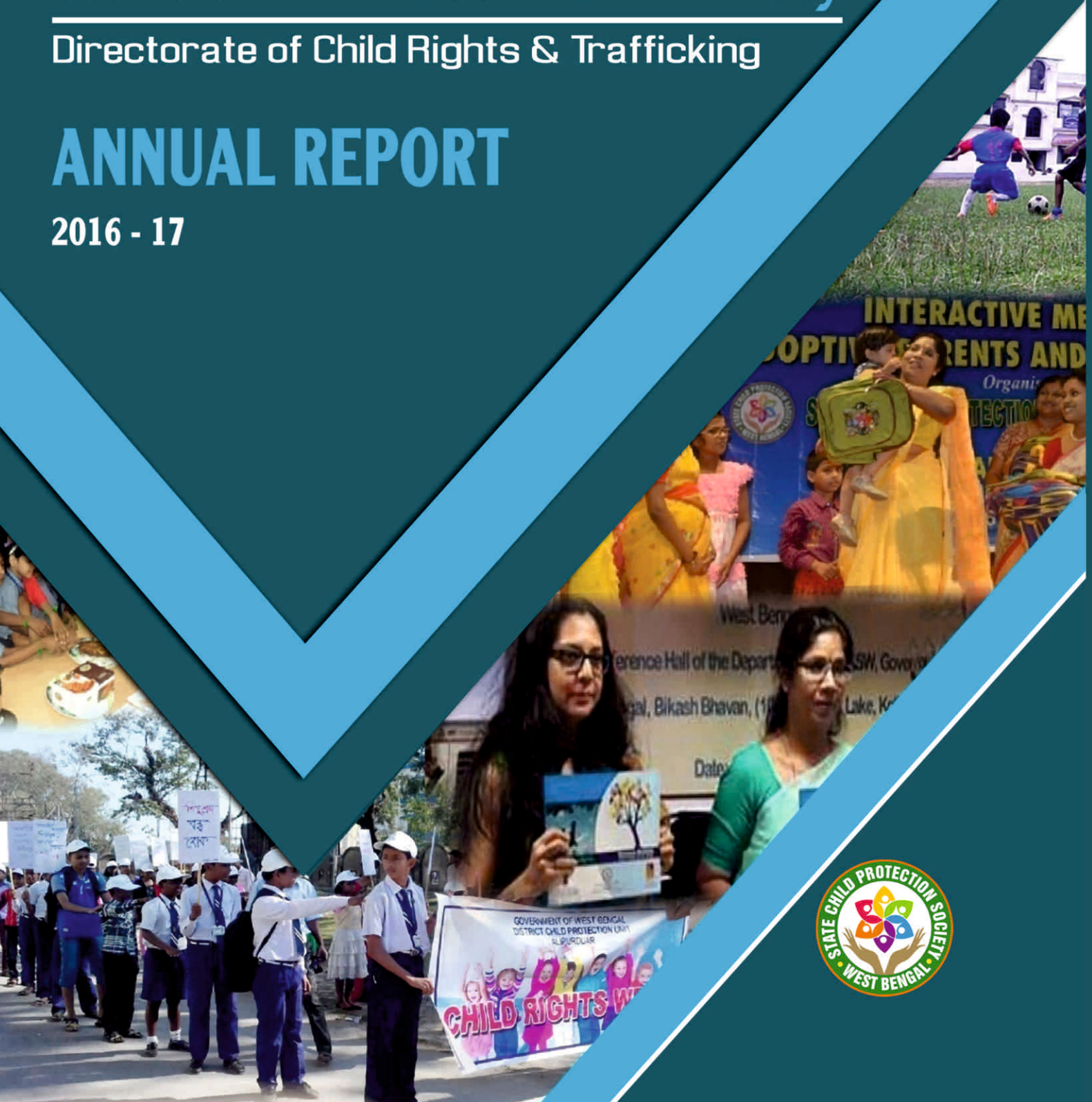

It was a platform for exchange, interaction and exposure. We were appreciated for some of our initiatives like Track CHILD and case management tools introduced in CCIs in partnership with our NGO partners. We also got to know about initiatives of our neighbouring States, some of which we would like to replicate in our state too.

I hope that through concerted efforts, all social evils affecting our children will be eradicated and our children will be able to grow up in a conducive and safe environment.

I congratulate the Directorate of Child Rights and Trafficking and the entire ICPS team for their initiatives and notable achievements for the betterment of children.

Message

As I sit down to pen my thoughts, SCPS continues to fight against violence and abuse of children with renewed vigour. The focus now is on restoration and reintegration of children who have been inhabiting the CCIs for many years. The vocational training component has been geared up through collaboration with government training institutes and NGOs. For the next few years Aftercare will remain a priority area for us. This is necessary as the ultimate goal of any scheme is to build responsible citizens who will contribute meaningfully towards the society. Alongside vocational training, counselling of children continues to be another priority area. We are now in the process of creating a pool of trained counsellors with the help of a technical agency. We will also try to reach out to those children who lack formal education and are leading a completely demotivated life. Bringing them out of the CCIs and mainstreaming them in the society remain our biggest challenge.

We have also completed the Phase I training of Master Trainers of CPCs with co-operation from the districts and in collaboration with our NGO partners. The training has been rolled down to the Block level CPCs in a few districts. We will also facilitate such training in other districts in the near future. Building a community based safety network for children is no longer a distant dream – the bright rays of hope are already visible in the horizon.

All of this would not have been possible but for the constant encouragement and guidance of our Chairperson and Executive Chairperson. I would also like to express my gratitude to all the officials of the Directorate, SCPS functionaries and UNICEF consultants who have put in a lot of effort in the execution and monitoring of the programmes carried under the aegis of the society and also in bringing out this publication.

Integrated Child Protection Scheme

A child's right to protection from any real or perceived danger to his/her life, personhood or childhood, is central to the assertion of all other rights of the child. This protection needs to be extended to all children, especially those who are vulnerable and need special attention (identified as “*children in difficult circumstances*”, owing to their specific social, economic and geo-political situations). It is, therefore, imperative that steps be taken legislative, policy, and otherwise to provide care, support and protection to children, in order to be able to meaningfully fulfil our constitutional and international commitments on this front.

The Integrated Child Protection Scheme (ICPS) is a Centrally Sponsored Scheme, which was launched in 2009 in partnership with the State Governments/UT Administrations. Since its launch, it has strengthened prevention of child rights violation; enhanced infrastructure for protection services; provided financial support for implementation of the Juvenile Justice (Care and Protection of Children) Act, 2000; increased access to a wider range and better quality of protection services; increased investment in child protection and is continuously drawing focus on the right of all children to be safe. ICPS has significantly contributed to the realization of Government/State responsibility for creating a system that will efficiently and effectively protect children.

The State's commitment in alignment with National Policy for Children, 2013:

The State is committed to take affirmative measures to promote and safeguard the right of all children to live and grow with equity, dignity, security and freedom irrespective of tradition, caste, creed, sex, religion.

Based on the cardinal principles of “*protection of child rights*” and “*best interest of the child*” the scheme envisages providing institutional care in housing children in different Child Care Institutions registered under Juvenile Justice (Care and Protection of Children), Act, 2015 and non-institutional care (Adoption, Sponsorship and Foster Care) to the children in difficult circumstances through different stakeholders at various levels. In order to ensure effective service delivery ICPS is implemented by setting up *State Child Protection Society (SCPS)* and *District Child Protection Units (DCPUs)* as the elementary unit of implementation at State and district level respectively. *State Adoption Resource Agency (SARA)* shall function as a unit under the SCPS.

The fundamental unit for implementation of the scheme at state level is the State Child Protection Society (SCPS)¹. It also acts as the nodal unit for implementation of the Juvenile Justice (Care and Protection of Children) Act, 2015 and other legislations and policies of child protection in the state.²

State Child Protection Society (SCPS)

The State Child Protection Society is primarily responsible for effective implementation, supervision and monitoring of ICPS and all other child protection programmes, agencies and institutions at the state level. The society acts in convergence with all the inter-sectoral and intra-sectoral departments of the Government along with the voluntary and civil organizations working in the field of child rights and protection through different consultative meets and workshops. SCPS also provides training and organizing capacity building programme of all personnel comprising of both government and non-government working under the child protection system. Being the nodal unit, it facilitates the capacity building and operationalization through formation of child protection committees and formulation of operational guidelines for the child protection committees throughout the state. Moreover, SCPS is also in-charge of maintaining state level databases of children in institutional care and family based non-institutional care and updates it on a quarterly basis utilizing the Track CHILD 2.0 portal.

The rights of a child are interrelated and interdependent and each one of them is equally important and fundamental to the well being and dignity of the child.

Every child has the right to life, survival, development, education, protection and participation.

State Child Protection Society under aegis of Directorate of Child rights and trafficking, Government of West Bengal moved forward with determination to build on that progress



working together with various units, agencies and institutions to find new ways of realizing the rights of every child especially the most vulnerable and disad-vantaged.

State Child Protection Society through its district level service delivery structure has put in efforts to support the most vulnerable children and their families improve the status and well being through child protection mechanisms. “Family is the best place for the child”. This is one of the guiding principles of ICPS. Following this principle, the present focus of SCPS is on restoration, reintegration and alternative care for children presently staying in the Child Care Institutes. Although it is imperative that the duration of the stay of children in such institutions is limited to a minimum possible period, it is equally important to maintain quality standards of care for serving best interest of institutionalized children.

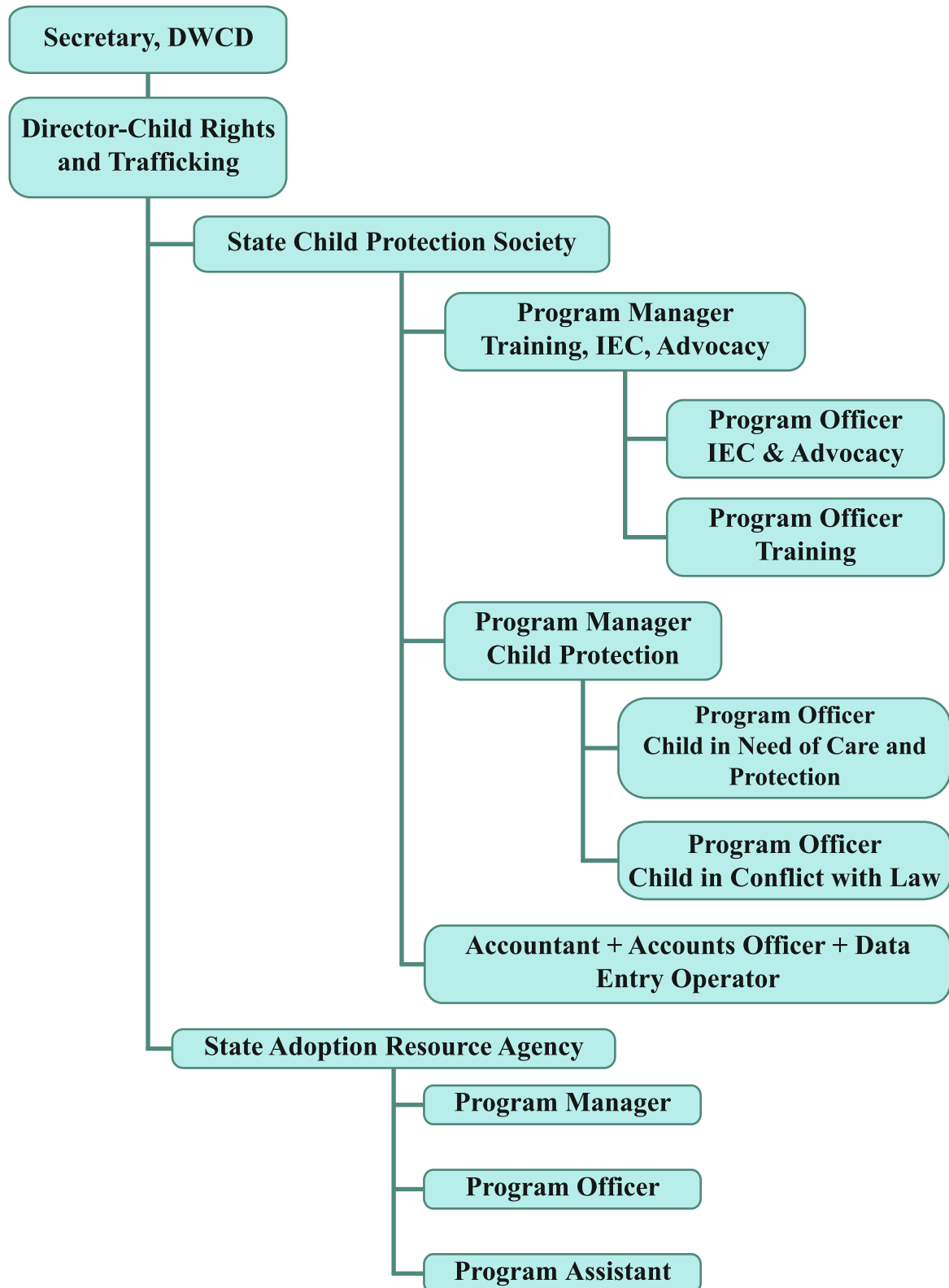
Vulnerability mapping and need assessment for identification of vulnerable children and families of all the districts have been conducted based on which annual action plan for child protection has been mapped. SCPS has actively coordinated capacity building workshops and dissemination workshops for all the stakeholders primarily focusing on rehabilitation and post rehabilitation of children. SCPS has strongly partnered with expert institutions in advocating for child protection. It has also played an important role in creating a pool of master trainers in each district who will be the torch bearers in strengthening the child protection committees. A good number of inter-state restorations of 109 children and repatriation of 107 children of Bangladeshi national has been conducted in active collaboration with the West Bengal Task Force. Convergent actions with line departments such as Police, CID, BSF, and Judiciary & Technical Education have been

initiated for rescue, rehabilitation and reintegration of children. During the year, emphasis has been given on alternative care where about 93 percent of children have been adopted within the country and 7 percent from different countries. Almost 181 children have been provided support through sponsorship scheme across the state. SCPS has played a key role in strengthening the child tracking system by capacitating the stakeholders working with the Track CHILD 2.0 portal.

The Annual Report of SCPS, 2016-2017 highlights the activities of SCPS which is focused on multiple activities like workshops, capacity building, coordination and convergence with line departments etc.

Capacity Building

Child protection is a complex subject and needs a comprehensive and multi pronged approach. For effective implementation of the programme, SCPS believes in capacitating and skill building of the functionaries depending on the need. It also believes in conducting research studies to explore new areas of intervention for improving the rehabilitation of children through institutional mechanisms and non-institutional mechanisms. Based on these guidelines, new proposals for children homes are also processed. The activities of different agencies, units and institutions are also reviewed periodically for identifying the gaps and providing practical solutions in mitigating the challenges. Capacity building of ICPS functionaries was carried out throughout the year. The highlights of some of the major training conducted are outline below.

Training of DCPOs (Phase-I)

Training of District Child Protection Officers (DCPOs) on roles and responsibilities linked to job competency was organized by SCPS in collaboration with Save the Children at Hotel Golden Park. Director, Child Rights and Trafficking inaugurated the programme and officers of Directorate of Child Rights and Trafficking and SCPS persons were present during the training. Representatives of Save the Children and other consultants facilitated the training. It was a five-day training workshop held from 19.09.2016 to 23.09.2016, where the facilitators tried to emphasize on job competency and occupational standards of District Child Protection Officers. The training introduced DCPO's to competency based training and assessment programmes which tried to build and enhance job skills and ensure uniformity in knowledge on Child protection which in turn will facilitate systematic implementation and

delegation of work.

Training of DCPOs (Phase-II)

The four day residential training programme spanning from the 07.10.2016 to the 10.10.2016

at Hotel Hindustan international, is a second phase of a three stage process of capacity building for District Child protection officers (DCPO's) on the Integrated Child protection Scheme (ICPS). The training was organized by SCPS in collaboration with Save the Children. As a continuum of skills enhancement and clarity of job descriptions of the DCPO and other team members, a second module of training was introduced in Phase II. The current training programme was designed to be more introspective thus allowing DCPO's to reflect on key skills and qualities required to drive, manage and lead their teams. This would be supplemented by authentic and valid evidences collected from the field that would in turn feed into evidence based portfolios. Assessors and external mentors appointed by Save the Children in consultation with the Sate Child Protection Society will further guide and supervise the process of evidence building, post the training workshop.



Training of Social Workers (DCPU)

A two-day training of Superintendents of Government run homes, social workers and outreach workers of all the District Child Protection Units (DCPUs) was held at ICMARD Building from 26.04.2016 to 27.04.2016. The training was facilitated by child protection experts who carried out the training on Integrated Child Protection Scheme (ICPS), prevention of human trafficking, restoration and repatriation of children. The objective of the training was to orient the Superintendents, social workers and outreach workers on the components of ICPS. The participants were also enlightened upon the causal pathway and consequences of human trafficking. Different participatory methods were carried out in the training to understand the methods of prevention of human trafficking; various outreach activities that can be conducted on creating awareness on prevention of human trafficking, procedures of restoration and repatriation of children.

Training of Home Superintendents

A one-day orientation on anti-human trafficking and standards of care for the Government run Home Superintendents of Murshidabad, North 24 Parganas, Nadia, Bardhaman, Purulia, Paschim Medinipur and Bankura was organized in Central Bank Officer's Training College on 18.08.2016, where the Directorate Officers, Child protection experts, representatives from Praajak and Angaan Trust facilitated the sessions. The training started with the sharing of objectives and overview of trafficking. The facilitators tried to define trafficking and provide information on the national and state scenario of human trafficking through situation analysis. Subsequently, the participant made an effort to conceptualize on restoration, repatriation of children and role of superintendents in

facilitating the children who are victims of trafficking. The training concluded with the group work on standards of care where the roles and responsibilities of the superintendents in implementing standards of care were highlighted for effective functioning of the child care institutions.

Training on Managing Children with Special Needs

A two-day training programme on children behavior and mental health was organized by

SCPS in collaboration with JPISC, supported by Terres Des Hommes. The participants were CWC Chairperson/members and superintendents from Government run Juvenile Justice Homes across West Bengal. The training was based on dealing with the psychological aspects of children in need of care and protection. These children are rescued from extreme difficult circumstances that often turn violent and show abnormal behaviours. Hence, mental health experts associated with different organizations were requested to share their experience and interact with the participants to help them deal with these children. The training was held at ICMARD building from 16.11.2016 to 17.11.2016.

Capacity building programme of Probation Officers (DCPU, Observation homes, Correctional Homes)

A two day capacity building programme of Legal cum Probation Officers, Probation Officers

to 01.03.2017. The training programme included orientation on Integrated Child Protection Scheme, Juvenile Justice (Care and Protection of Children) Act, 2015, child psychology, functioning of Special Juvenile Police Unit (SJPU) and roles and responsibilities of the LCPOs. It has been felt that there is a lack of clarity about the roles and responsibilities of the LCPO. It is important for them to know in detail the need of having the Social Investigation Reports and its preparation. Simultaneously, it is important for the LCPOs to understand the child psychology and minimize the stigma attached with the children in conflict with law and their families. Thus, to address all these issues, the resource persons facilitated the training in a two way learning process and sharing of experiences to make the workshop successful.



Coordination and Convergence

Meeting of Project Sanctioning Committee

A meeting of Project Sanctioning Committee of SCPS was held at Conference Hall, 10th Floor, Bikash Bhavan on 23.02.2017 for approval of new proposal for FY 2017-2018. The meeting was chaired by Secretary, Dept. of WCD&SW, Gov. of West Bengal, convened by Director, Child Rights Trafficking. Officers of the Directorate of CRT, SCPS, and UNICEF persons were present in the meeting. A threadbare discussion was made on the functioning of the existing projects, proposals of new projects and financial aspect of the projects. The concerned DCPUs will continue to monitor the Open Shelters. The new proposals for setting up of Child Care Institutions submitted by DCPU were discussed in detail. It was also discussed that some of the SAAs are keeping children above their sanctioned strength. Followed by these discussions in details, the meeting ended with a vote of thanks.

Meeting of the Executive Committee of State Child Protection Society

Meeting of the Executive Committee of State Child Protection Society was held on 18.04.16 at Conference Hall, Bikash Bhawan. The meeting was chaired by Ms. Roshni Sen, Secretary, WCD & SW, Government of West Bengal & Executive Chairperson, State Child Protection Society. The meeting was attended by senior government officers of WCD & SW, Government of West Bengal, other line Departments, and representatives from prominent NGOs who are members of the Executive Committee. The proposals approved by the Project Sanctioning Committee for FY

2016-17 were placed before the committee for taking further decision. The activity report of SCPS was placed before the committee. Progress in formation of Child Protection Committees, mechanism of village convergence, proposals for new CCIs, initiation of signing of MoU on restoration and transfer of children rescued from trafficking and other exploitative situation has been initiated with Karnataka Government was shared in the meeting.

Annual General Meeting

Annual General Meeting of SCPS was held at the 10th floor Conference hall of Bikash Bhavan

on 24.08.2016. Honourable Minister (Independent Charge), Secretary, Commissioner, Deputy Secretary, Director, DCRT, Directorate Officers, SCPS persons, Officers from other Departments, Governing body members, Representatives from different NGOs were present. Annual activities and financial audit were discussed; SCPS website was inaugurated; SCPS Annual Report (2015-16) and a Resource Directory of ICPS stakeholders of Kolkata district were also released. The meeting started off by highlighting the major achievements of



SCPS. The Department of Woman and Child Development and Social Welfare has been awarded **Gold in e-governance for Track CHILD 2.0 and Skoch award** for its commendable work in prevention of human trafficking. Setting up of model CWCs, introduction of health cards, notification of after-care guidelines were also remarkable achievements that was mentioned in the meeting.

State Workshop on Assessment of Juvenile Justice System and NGO services

A workshop was organized by Directorate of Child Rights and Trafficking and UNICEF on 08.07.2016 at CII, Salt Lake on assessment of Juvenile Justice System in West Bengal of Government run homes, particularly through NUJS and UNICEF, and individual assessment of NGO homes by Ms. Bipasha Roy, with an objective to inquire on the components of standards of care followed in the Child Care Institutions, like health and hygiene, education, vocational training, individual care plan etc. The study on assessment of Juvenile Justice System conducted by NUJS and UNICEF involved the entire system like Child Welfare Committees, Juvenile Justice Boards, District Child Protection Units, Child Care Institutions entrusting upon the functioning of the units and the process of improving the functioning of units. However, the individual assessment was carried out to understand the support services provided by the NGOs in different CCIs. The findings of the research study were shared with the Superintendents of the Child Care Institutions. A lot of queries related to administration came into floor which was discussed through a group work and interactive discussion.

PAB Meeting through Video Conference

The meeting on Project Approval Board of Ministry of Women and Child Development was held at Bidyut Bhavan on 25.07.2016 through Video conference. This meeting was conducted to discuss the issues on ICPS programme and financial allocations during the year 2016-17. The Secretary of the department conducted the video conference on behalf of the State while on the other side Secretary, Ministry of Women and Child Development was there. During the meeting, the State Government requested for construction of two Government run CCIs in Darjeeling and four NGO run CCIs. The state was requested to submit the actual list of CCIs both Government and Non-Government and Open Shelters. The State Government was also asked to inquire about the case pendency and Home Study Report, information related to database, monitoring reports were also asked to submit and the release of grants for new proposals were discussed.

Meeting of Committee for drafting of JJ rules

A meeting was held in the conference hall of Bikash Bhavan on 03.10.2016 for discussing and finalizing the dates for meeting of sub committees comprising Government Officials and NGO representatives, for framing of state JJ rules. The meeting was chaired by Deputy Secretary, Dept. of WCD & SW, Government of West Bengal. DCRT Officers, SCPS persons, UNICEF consultants, Law Officer and NGO representatives were present in the meeting. Different committees for framing rules for :

1. Children in Conflict with Law
2. Children in Need of Care and Protection
3. Statutory Bodies
4. Child Care Institutions



5. Non-institutional Care
6. Restoration and Repatriation

A series of meetings of different committees were held for framing the state JJ rules and the suggestions provided by the different committees were incorporated in the state JJ rules for finalizing the document.

Review Meeting

A review meeting in connection with implementation of Juvenile Justice (Care and Protection of Children) Act, 2015 was held at the conference hall of Bikash Bhavan on 09.12.2016 chaired by Ms. Roshni Sen, Secretary, CD, WD & SW. Mr. Bedanga Biswas, Dy. Sec. CD, WD & SW, Ms. Richa Misra, Director, CRT and other officers were present in the meeting. The following agenda were discussed :

- ❖ Registration of CCIs under the new JJ Act, 2015.
- ❖ Registration of residential institutions housing children, run by other departments and individuals.
- ❖ Registration of open shelters as CCIs under JJ Act.
- ❖ Selection committees for CWC and JJB.
- ❖ Composition of inspection team and other committees under JJ Act.
- ❖ Service Rules of DCPO and other DCPU staff.

Meeting in connection with CP issues in NGO run Homes

A meeting in connection with CP issues in NGO run Homes was held at ICMARD building on 29.12.2016 chaired by Hon'ble Minister of State, Child Development, Women Development & Social Welfare (Independent Charge,

Chairperson, SCPCR and other Higher Officials were present. Representatives from

different NGO run Homes, PO-IC, CWC members were present in the meeting. It was mentioned that standards of care in most of the CCIs need improvement. The increasing cases of escape from the homes will not stop unless the home authorities change their attitude and treatment towards children. Superintendent must be residential. The CCIs were requested to provide a status report of children above 18 years of age staying in the homes in order to expedite their rehabilitation. It was also discussed that restoration and repatriation should be regularized.



Special Days and Events

Observation of Child Protection Day

Child Protection day was observed at Rabindra Sadan, Kolkata on 09.06.2016. Dr. Shashi Panja, Minister of State (Independent Charge) for Women and Child Development and Social Welfare, inaugurated the programme. All children from CCIs across the state, along with child protection functionaries, participated in the event. The programme was organized by Department of Child Development, Women Development and Social Welfare in collaboration with West Bengal Commission of Protection of Child Rights. It was a gala event where the dignitaries addressed on different issues of violation of child protection. The importance of child rights was elucidated in the event and how it impacts the life of every child. The children participated in the events through different cultural programmes. Children who scored high marks in the board exams were felicitated by Honourable Minister of State (Independent Charge) for Woman and Child Development and Social Welfare, Government of West Bengal.

Adoptive Parents meet

An annual meet for Prospective Adoptive Parents was organized by State Child Protection

Child Rights Day was celebrated at EZCC hall on 21.11.2016 conducted by State Commission for the Protection of Child Rights. WBCPCR Chairperson, Director, CRT and other senior officials were present in the meet. Persons from SARA, Persons from DCPUs across West Bengal, NGO representatives participated in the programme. Children from different Child Care Institutions performed various cultural programmes. Eminent personalities and dignitaries participated in the meet whose august presence enlightened the children. This day was celebrated in every district of West Bengal through various events like tram ride, dancing, singing, theatre, procession, sports and other awareness generation programmes. The children from different homes, schools and community actively participated in the event.

Juvenile Justice (Care and Protection of Children) Act, 2015 – Focus on Rehabilitation Services and Linkages with the POCSO Act, 2012 was held at Hotel BNR Chanakya, Ranchi on 11th and 12th February 2017. This was organized by the Supreme Court Juvenile Justice Committee and hosted by Jharkhand High Court. The Conference was supported by UNICEF in partnership with Department of Women and Child Development, Govt. of Jharkhand. Technical support was provided by Centre for Child and the Law, NLSIU, Bengaluru. The participating States were Jharkhand, Chhattishgarh, Bihar, Odisha and West Bengal. Andaman and Nicobar islands were also included as they are under the jurisdiction of High Court, Calcutta. The persons from SCPS participated in the conference and shared their best practices in rehabilitating children that has been done in partnership with non-governmental organizations.

Meeting with NGOs working in Govt. Homes

A sharing meeting on assessment of NGO services in Government run JJ Homes was held

at the conference hall of Bikash Bhavan on 21.09.2016 with the different NGOs. The study was conducted by Dr. Bipasha Roy and she shared her findings with the NGOs. Director, CRT, Dy. Director, CRT, SCPS persons and UNICEF consultants were present in the meeting. Representatives from CINI, Save the Children, JPISC, Kolkata Sanved, Prajaak, Aagan Trust, SLARTC etc were present in the

It was shared that different NGOs provide different types of support services to the children homes like health, formal education, vocational education, life skills etc. yet their service is restricted to the children homes situated in Kolkata and in the outskirts. It was suggested if the support services can be extended across the state following uniform tools and techniques for rehabilitating the children.

State Level Consultation

A state level consultation was carried out by the Department of Women and Child Development and Social Welfare and SCPS in collaboration with Praajak and JPISC at Tangerine Hall Banquet on



16.11.2016. Honourable Minister (Independent Charge), and senior officials were present in the meeting. Persons from SCPS, Superintendents from Govt. run JJ homes, CWC chairpersons/ members across the state participated in the consultation meet. It was a dissemination workshop where Prajak elucidated on the experience of working in the children homes by enhancing standards of care and promoting child friendly actions among the caregivers and other staffs associated with CCIs.

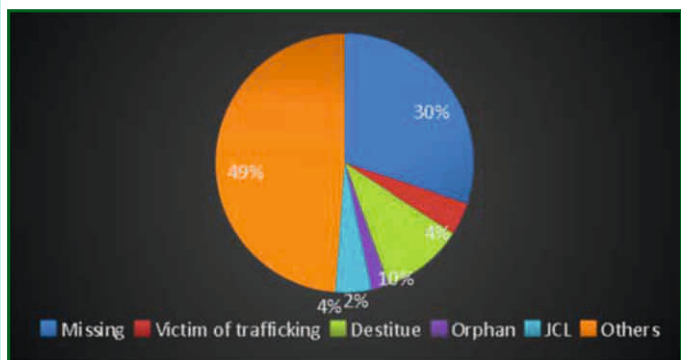
SCPS plays a fundamental role in strengthening the institutional services by creation of new institutional facilities and maintenance of existing institutional facilities for both children

in conflict with law and children in need of care and protection. These include shelter homes, children's homes, observation homes, special homes and place of safety. In addition, there is also a provision of institutional care of children with special needs by supporting a specialized unit within the existing home or by setting up a specialized shelter home. With an aim to effectively execute the service different capacity building workshops, orientation trainings innovative mechanism were engendered among the functionaries to equip them with adequate skills and knowledge on their roles and responsibilities and improve the minimum standards of care for the children.

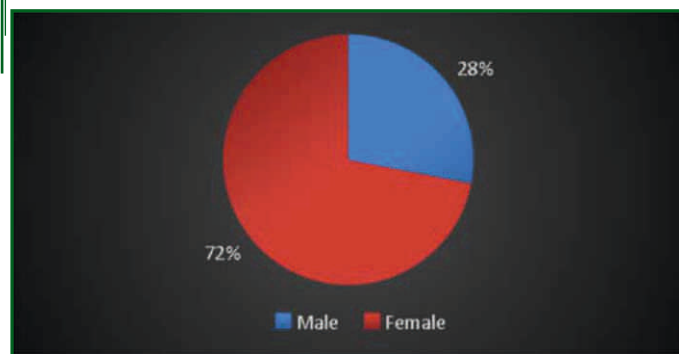


Children in the Child Care Institutions

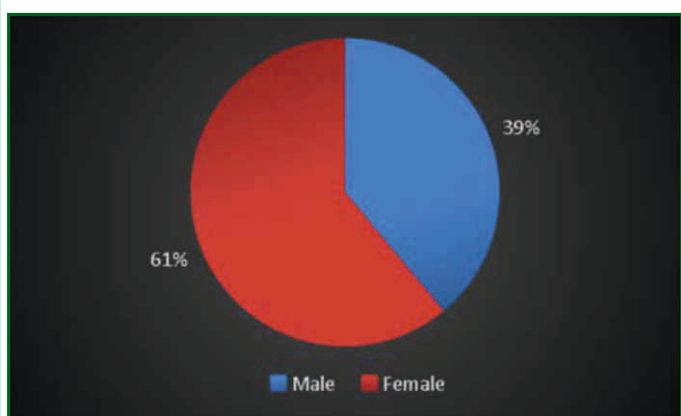

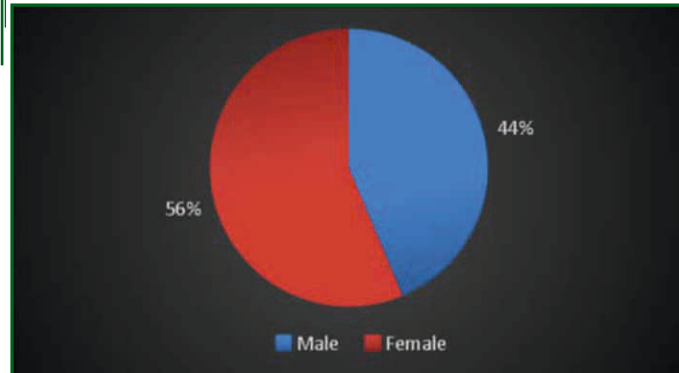
Graph 1- Different categories of children admitted in Child Care Institutions



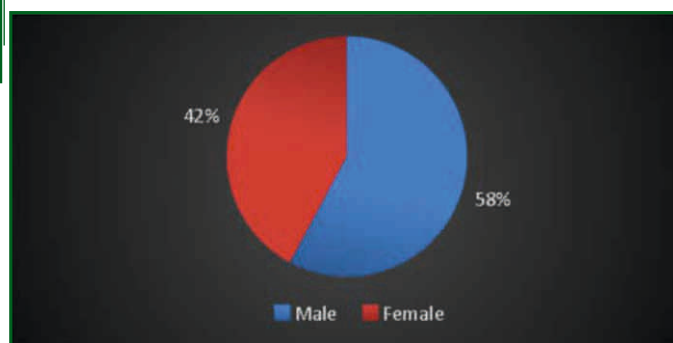
Graph 3- Percentage of Missing Children in Child Care Institutions

Open Shelter

The largest numbers of homeless children, street and working children, child beggars reside in urban and semi-urban areas. ICPS caters the need of such children including prevention, treatment and rehabilitation through services of Open Shelter. The Open Shelters are to be placed in urban and semi-urban areas run by both NGO and Government that are not meant to provide permanent residential facilities for children but will complement the existing institutional care facilities. Open Shelters have the provisions for health care, formal education, vocational training, recreational activities to harness their talent and potential giving them the opportunity to become productive citizens. There are 25 Open Shelters spread over Kolkata, North 24-Parganas, South 24-Parganas Howrah, Jalpaiguri and Darjeeling. Some of the notable activities conducted with the children of Open shelter -

The children enjoyed the meet and participated with full energy. They took part in many events like sprint, hitting the wicket, balance race, go-as-you, like etc. Medals and Trophies were awarded to the successful participants. Participants were also given certificates and consolation prizes. Department of CD, WD and SW arranged sports uniform for all 600 children who took part in the meet.

Aftercare

After Care refers to the provision of care for children, including children with special needs, after they have reached the age of 18 years till 21 years. It is to help prepare these young adults to sustain themselves during the transition from institutional to independent life. The State Government is mandated by the Juvenile Justice (Care & Protection of Children) Act, 2015 vide Sec 46 to set up an after care programme for care of juveniles or children after they leave special homes and children's homes to facilitate their transition from an institution-based life to mainstream society. Hence, Children going to complete 18 years of age in the Children's / Special Home, without any family fit to take care of them and who is willing to undertake the training in After Care will be considered for the After Care programme. After care organizations shall provide counselling services, vocational training, and linkages with corporate and civil society groups, health services, volunteers and life skill programme for their betterment.

Based on these cardinal principles it has been a constant endeavour to rehabilitate the vulnerable children housed in the Child Care Institutions by various ways. These children belonging to the different vulnerable groups are rehabilitated through formal education, extra-curricular activities and vocational training according to their ability, eligibility and interest. The State Government is now primarily focusing on training the children on various market-linked occupational activities. Since, vocational training prepares the children for a specific trade and it directly develops expertise in techniques and skills, the children gets an exposure to the employability sector that enables them to build a descent career, empowering their lives through economic independence. At present, aftercare is available in the following homes :

With an aim to generate livelihood of the children especially above eighteen years of age, the Government has taken an initiative of providing different vocation education through Government and non-government partnerships across the state. The trainings are being imparted by various institutions like Industrial Training Institute and other private companies who also help the students in linking them with

the respective companies. Presently, the children who have got the opportunity to get training in the trades are earning monthly 7000 to 9000 approximately as they have been placed in different companies like KFC, Pantaloons, Au Bon Pain etc.

Case Study

Art and Craft workshop by RIHAD at Shilayan Government Home in Murshidabad

Art and craft workshops have been organized for 62 girls of Shilayan Government Home. Classes were conducted once in every week. One of the main thrust of these workshops was to explore the creative zeal within these girls. Efforts were made to make them understand that art and craft can be made through anything available around them. These workshops were supporting these girls to develop art and craft with low cost materials and waste materials. Mixed media on paper was used as medium, particularly, during painting development. Thus, through utilizing materials, that were easily available to them, these girls have been empowered to create innovative art and craft works. Sincere attempts have been made to make them realize that to be an artist one needs a mind of a creator, artistic sense and passion to create something innovative and vent out their

feelings. Costly art materials are not a necessary thing for developing art work. Different endeavours have been made to enhance their skills through simple but interesting techniques to create innovative forms of art and craft using materials such as news paper, glossy magazine paper, cap of bottle, torn cloths, dry leaf, plastic cups, bottle of water, bottle of cold drinks, broken bangles, old bag, water colour, pastel colour, dry seed, wool, broomstick, plate and glass of thermocol etc. All the sessions were done in an interactive manner. The girls were encouraged to experiment in their own way to create something new. Moreover, emphasize was given on expressing their feelings about their art works. Thus small initiatives have been taken towards uplifting their confidence on their own selves.





Non-Institutional Care

State Adoption Resource Agency

“State Adoption Resource Agency” (SARA) is the agency set up by the State Government under the Integrated Child Protection Scheme and as per section 67 (1) of Juvenile Justice (Care and Protection of Children) Act, 2015 and JJ model rules 2016. SARA is a unit of SCPS (State Child Protection Society) in West Bengal to monitor and supervise the non-institutional care namely adoption, sponsorship and foster care under ICPS. SARA is functioning as the State Level Resource Centre in coordinating, monitoring and developing the adoption program in the State and to facilitate the setup of Specialized Adoption Agencies (SAA). It promotes in-country and regulates inter-country adoption in coordination with Central Adoption Resource Authority (CARA). SARA supervises the work of SAAs and ensures coordination between them within the state. The agency also supervises and monitors the sponsorship and foster care programmes throughout the state. Presently there are twenty three functional Specialised Adoption Agencies in the state.

Throughout the year various programmes were undertaken to strengthen the non-institutional care initiatives that are highlighted below.

Hands-on Training on CARINGS

A one day hands-on training on CARINGS was organized at Conference Hall, Bikash Bhavan for the newly registered Specialised Adoption Agencies on 13.04.2016. A review meeting on the related activities of Specialized Adoption Agencies was also held on the same day. CARINGS is an online portal which is used by Central Adoption Resource Agency to maintain a centralized database of prospective Adoptive Parents, number of children declared as “Legally

Free for Adoption”, home study reports and different Specialised Adoption agencies. The database is maintained by CARA, SARA and the information is uploaded and updated by the district level stakeholders. The objective behind such online mechanism is to prevent illegal adoption. New Specialised Adoption Agencies have been registered and with a view of capacitating them, a review meeting cum orientation workshop was conducted to introduce them to the portal and explain its utility to the participants who attended the meeting. A status review was also carried out with the existing SAAs and encouraged to raise their doubts which were clarified by the officers and experts.

Interactive workshop on issues related to Inter-Country Adoption

An Interactive workshop on issues such as inter country adoption online process, documentation related to inter-country adoption, with a special emphasis on child study report, medical report and home study report, along with role and networking with different stakeholders for foreign adoption and other topics related to Inter-Country Adoption was organized by the State Adoption Resource Agency (SARA), West Bengal at the Conference Hall, 10th Floor, Bikash Bhavan on 25.05.2016. The workshop comprised of representatives from different SAA who regularly deal with the cases of in-country and inter-country adoption. The workshop initiated with a brief discussion on the problems and challenges faced by the social workers of the SAA in dealing with the parents or any other person related to adoption. They also sought solution to the legal and financial implications which many parents are reluctant to perform. The facilitators tried to clarify their

doubts and questions. Followed by this interaction, the facilitators pointed out on the quality of the documents related to inter-country adoption, communication skills, and standards of child study report, medical report and home study report which is making the entire process slow and compelling the parents to take necessary action against the agency. The facilitators requested the trainees to improve their qualities and increase networking and coordinating with the foreign agencies to speed up the entire process of adoption.

Workshop on conducting Home Study Report in connection with Adoption

A one day orientation workshop was held at ICMARD building on 01.09.2016 with an

objective to capacitate the social workers of Specialized Adoption Agency across West Bengal to conduct Home study report, Child Study Report and Medical Examination Report. Resource persons from Directorate of Child Rights and Trafficking, SCPS, SARA, UNICEF and SAA were present in the workshop. The facilitators tried to highlight the technicalities of filling up of forms and reduce pendency in the CARINGS portal through mock sessions and interactive discussions. The

objective of the workshop was to orient the coordinators and the social workers of the SAAs to fill up quality home study reports and improve their skills of communication and counselling. The first part of training dealt with the importance of adoption and the proportion of prospective adoptive parents to adoptable children. A group exercise was conducted on filling up of the home study report. Furthermore the second half of the training was facilitated through role plays and mock session where the social workers had to counsel the parents. It was participatory training where the participants were provided with hands on practice imperative to their roles and responsibilities.

State Consultation Meet on Alternative Care

A State Level Consultation Programme on Alternative Care for Children under ICPS was organized at The Stadel, Salt Lake City, Kolkata on 22.07.2016 by Department of Child

Development, Women Development and Social Welfare and supported by SCPS, West Bengal and UNICEF under the chairmanship of Hon'ble Minister of DWCD, W.B. The consultation took place in presence of higher officials of the Department of Woman and Child Development and Social Welfare, Government of West Bengal,



Directorate of Child Rights and Trafficking, UNICEF, experts on alternative care. The participants were provided inputs on the concept of alternative care especially foster care. The experts who had come from other states elucidated the components of Integrated Child Protection Scheme. The National policy of children along with the evolvement of importance of child protection was highlighted. Experience sharing on the subject was carried out with the states of Maharashtra, Rajasthan and Karnataka who shared their initiatives on foster care and how those models can be adopted in the context of West Bengal.

Training on CARINGS in collaboration with CARA

An orientation training of DCPU staffs, CWC members, SAA representatives and NGOs from

Jalpaiguri, Malda, Darjeeling, Murshidabad, Coochbehar, Alipurduar, Dakshin Dinajpur was organized in Siliguri on 10.09.2016 to highlight SAA-CCI linkage, technicalities of the online system, along with a discussion on modalities for reducing pending Legally Free for Adoption certificates. Resource person from CARA was present to facilitate the training. It was felt that

the DCPU staffs especially Protection Officer-Non Institutional Care, CWC members do not have a conceptual clarity on the CARINGS portal and uploading of information. The dashboard of the portal reflects a huge number of case pendency due to incomplete information of children. Therefore, a capacity building workshop for the stakeholders was arranged to equip them with the knowledge and skills of using the portal and familiarize with their roles and responsibilities in facilitating the process of adoption.

Training on Adoption Regulation Guidelines, 2017

A one-day orientation programme on Adoption Guidelines 2017 was organized by State Adoption

Resource Agency on 07.02.2017 which included Protection Officer-NIC, Coordinator and Social worker of SAA across West Bengal. The workshop was chaired by Secretary, Dept. of WCD&SW, Govt. of West Bengal, Representative from SCPCR, officials from Directorate of Child Rights and Trafficking, SCPS, and SARA persons were present in the workshop. The participants were from the Specialized Adoption Agencies and Protection Officer-NIC from all the districts.

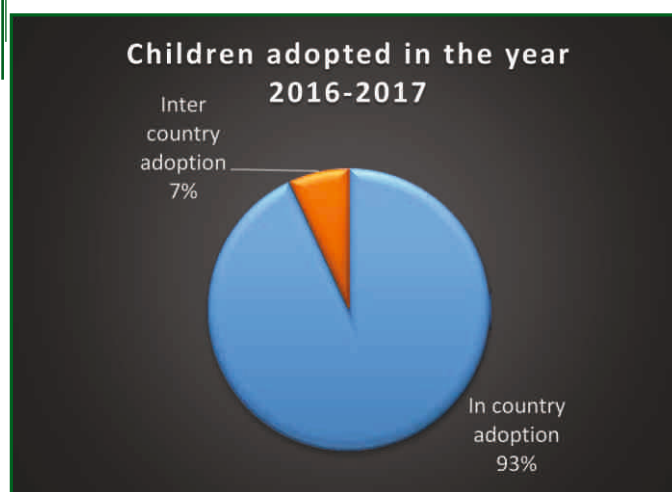
The resource persons tried to draw to the fact that more awareness is required in promoting legal adoption and vigilance in private nursing homes. As there is a huge pendency of cases from the end of CWC, and pendency of homes study report is also high, it was suggested that a pool of trained social worker to be prepared who will carry out the same to reduce the pendency. A lot of discussions took place related to CWC orders, different reports, providing legally free for adoption certificate to children, paper publication, and new set of norms mentioned in the guidelines, quality of care given to the children in SAA and regular monitoring and supervision of the agencies.

About 93 percent of children have been adopted within the country and 7 percent of children have been adopted from different countries through different Specialized Adoption Agencies with the help of State Adoption Resource Agencies (SARA), West Bengal. Adoption being a very sensitive issue, the entire procedure is continuously monitored and supervised by the state level authority.

Anti Trafficking Initiatives

One of the important programmatic components of ICPS defines the prevention of trafficking of children. State Child Protection Society and Directorate of Child Rights and Trafficking undertook various orientation workshops, meetings to discuss and address on the issue of anti-trafficking.

Training on Conducting and Reporting Home Study for the Victims of Trafficking

Training on Home Investigation Report of trafficked victims was organised by the State Child Protection Society and supported by UNICEF on 31.05.2016. The objective of the training was to orient the participants on fundamentals of Home Inquiry Report/Social Investigation Report. The training was attended by DCPU social workers and CHILDLINE members from Kolkata, Howrah, Nadia, Burdwan, North 24 Pargana, South 24 Pargana, Malda, Murshidabad and Jalpaiguri. There were participants from NGOs working on prevention of trafficking also. A proper HIR study leads to an early restoration of the child. The training propaganda tried to address the key problems and challenges faced by the social workers and CHILDLINE members in the HIR study. During the training was conducted where the participants were educated on step by step process of filling up of reports.

Meeting of State Advisory Committee

The 3rd meeting of West Bengal State Advisory Committee on Combating Human Trafficking for Commercial Sexual Exploitation, chaired by Hon'ble Minister of State, Child Development, Women Development & Social Welfare (Independent Charge) was held at Conference Hall, Dept. of Child and Women Development, & Social Welfare on 13.06.2016. The objective

of the meeting was a discussion on the finalization of the State Plan of Action on Human Trafficking, draft Trafficking of Persons Bill 2016, constitution of a district level Anti-Trafficking Committee, and development of a state level communication plan. The major agenda of the meeting was on finalization of State Plan of Action on Prevention of Trafficking. A brief presentation was made focusing on the objectives behind developing this plan, strategies, major pillars and activities and responsible departments to implement this plan effectively in the field. It was also discussed that awareness needs to be carried out FM radio channels and other media channels through a state level communication plan.

Meeting on Streamlining Repatriation and Restoration

A meeting regarding expediting repatriation of Bangladeshi children and women lodged in Govt. and NGO run Homes in West Bengal was organized under the chairmanship of Director, Child Rights and Trafficking on 20.7.2016, to seek the opinion of the stakeholders engaged in the process, to streamline the process, and to promote child friendly methods for safe and speedy repatriation. West Bengal being the both source and transit border for trafficking, innumerable trafficking activities of woman and children are carried out. In this process, a lot of Bangladeshi children and women get trafficked to India. These victims are often housed in the women homes and Child Care Institutions who need to be repatriated back to their country. Thus the meeting was held with the purpose to instigate the process of repatriation of Bangladeshi children through coordinating with different departments both the countries.

Interstate Workshop on Investigation of cases of Human Trafficking

The Department of Child Development, Women Development and Social Welfare with the

support of State Child Protection Society, West Bengal and UNICEF organized a two-day interstate (West Bengal and Maharashtra) workshop at Indis Mart Hotel, from 30.08.2016 to 31.08.2016, on investigation of cases of human trafficking. The objective of the workshop was to bring together police officers from both states, particularly those who are currently investigating cases of human trafficking in the two states, on a common platform and explore possible solutions to remove existing challenges and gaps in effective prosecution of the traffickers.

Meeting of the West Bengal Task Force

A meeting of the West Bengal Task Force on was held on 27.10.2016 in the conference hall of Department of Child Development, Women Development & Social Welfare at Salt Lake under the chairmanship of Secretary, Department of Child Development and Department of Women Development & Social Welfare, Govt. of West Bengal. The meeting was convened by Director, Child Rights and Trafficking. Several updates related to the activities of State Task Force and RRRRI of women and children was discussed in the meeting. Data on restoration

and repatriation of children, training and capacity building of the various stakeholders was also discussed. Some of task force members shared their learning on restoration and repatriation of children in their operation areas that can be taken up by the government in some of districts with porous borders.

Realizing the gap in understanding among different stakeholders about the repatriation process, it was decided to organize a training programme for the Superintendents and CWC members on the Repatriation Guidelines.

Interstate Restoration

A good number of inter-state restorations of children took place during the year. Many of these cases were of children who are victims of trafficking. The inter-state restoration are as follows:

Restoration: A case study

21 children were rescued from Hyderabad, Telengana, under Operation Smile III, by Govt of Hyderabad. The children were from different districts of West Bengal namely Uttar Dinajpur, Murshidabad, Purba Medinipur, Paschim Medinipur, Burdwan, Hooghly and South 24 Parganas. With support of DCPU Hyderabad, the children were brought back to West Bengal on 20th March by East Coast Express in the evening. They were received at Howrah Station by the CHILDLINE and DCPU North 24 Parganas from where they were taken to Kishalay Home, Barasat North 24 Parganas for temporary shelter. After production before the Child Welfare Committee, the children were restored back to their respective families with the support from CHILDLINE and the DCPUs of the respective districts.

Repatriation Status of Bangladeshi Nationals

During the year 145 Bangladeshi nationals were repatriated. The month wise break up for repatriation is as follows :

Support to Statutory Bodies

According to section 27(1) of Juvenile Justice (Care and Protection of Children) Act, 2015, the State Government shall by notification in the official gazette constitute for every district, one or more Child Welfare Committees (CWC) for exercising powers and to discharge the duties conferred on such committees in relation to children in need of care and protection under this Act. Similarly, according to section 4(1) of Juvenile Justice (Care and Protection of Children) Act, 2015, the State Government shall constitute for every district, one or more Juvenile Justice Boards for exercising the powers and discharging its functions relating to children in conflict with law. SCPS ensures that induction training and sensitization of all members of the committee and the board are provided as per requirement through expert and specialised organizations.

Training of CWC members

One-day training for the CWC members from Kolkata, North 24 Parganas, South 24 Parganas, Howrah, Hooghly, Bardhaman on Juvenile Justice (Care and Protection of Children) Act, 2015 and Standards of Care was organized at ICMARD building on 23.08.2016. The agenda of the workshop was on Overview of Juvenile Justice (Care and Protection of Children) Act, 2015, Role of CWC in implementing Non-institutional Care, Overview on Track CHILD 2.0, Minimum Standards of Care, and overview on the services available for children with special needs. The overall objective of the workshop was to equip the participants with adequate knowledge and skill so that they can have clarity in their roles and responsibilities as CWC members and can help in proper functioning of the committee. The training programme was conducted through group work, interactive

discussions and other participatory training methods.

Orientation of CWC members

An orientation training of CWC members of North Bengal districts, namely Jalpaiguri,

Malda, Darjeeling, Murshidabad, Coochbehar, Alipurduar, Dakshin Dinajpur, was held at Hotel Heritage in Siliguri on 09.09.2016. The programme was organized by SCPS in collaboration with Jayprakash Institute of Social Change. The training programme as based on Juvenile Justice (Care and Protection of Children) Act, 2015, roles and responsibilities of CWC members in adoption and anti-human trafficking. The training programme started with the welcome address of Director, Child Rights and Trafficking, where she mentioned about the pending cases being reported in the state as the committees are not functioning properly. She also stated about the importance of effective functioning of child welfare committees in order to address the issues of children in need of care and protection especially in adoption and human trafficking. This was

followed by experience sharing and interaction with the participants.

Training of JJB Social Workers

A two-day orientation training for the social workers of Juvenile Justice Board was held at

NUJS campus. The training was organized by NUJS in collaboration with SCPS and UNICEF.

The training covered Juvenile Justice (Care and Protection of Children) Act, 2015, POCSO Act, 2012, and the roles and responsibilities of social workers, JJB. All the social worker members of JJB across West Bengal participated in the training which was held from 18.01.2017 to 19.01.2017. The training imparted by the professors of NUJS and CCL Bangalore, enriched the participants with different laws and legislation especially Juvenile Justice (Care and Protection of Children) Act, 2015, POCSO Act, 2012. The trainers emphasized on the roles and responsibilities of the social workers of JJB where it was shared that it is imperative to know the reasons that pushed children to commit crimes. Effort should be made to ensure that children do not commit such crimes in future and this would be possible only by working closely with children.



Child Protection Committees

Formation and Strengthening of Child Protection Committees (CPCs) in West Bengal

A Child Protection Committee (CPC) is a community based group comprising duty-bearers who are primarily responsible for creating and promoting a child- friendly and safe community environment wherein all children's well- being, safety and rights are protected. The roles and responsibilities of the CPCs include monitoring, reporting and responding to issues of child protection in the community, planning and taking up innovative activities for raising awareness on child protection in the community. CPCs are also responsible for developing Annual Action Plan to address CP issues, referring and reporting cases to higher level CPCs and DCPUs and engaging stakeholders in raising awareness.

Under ICPS, CPCs at Block, Ward and Village levels are required to be set up with the help of district level ICPS functionaries. SCPS, West Bengal has played a key anchoring role in setting up CPCs at different levels. The CPCs at Block, Ward and Village (Gram Samsad) of levels were formed through collaborative efforts of SCPS and NGOs. Thereafter, CPC guidelines were formed for the functioning of CPCs under the supervision of DCPU and SCPS.

The objectives of the CPC trainings

- ❖ Assisting CPCs in recognising the importance of their role as a key child protection actor, particularly in terms of operationalizing community-based safety net for children.
- ❖ Orienting CPCs on specific core content areas to enable them to initiate functioning as mandated under the ICPS.
- ❖ Helping CPCs familiarize themselves with key formats/records and other procedural aspects.
- ❖ Aiding CPCs in understanding the importance of collaboration between key child protection actors including referral mechanisms.

After launching of the CPC guidelines, a need for developing comprehensive training modules was felt, to enable the Village Level Child Protection Committees (VLCPCs), Block Level Child Protection Committees (BLCPCs) and Ward Level Child Protection Committees (WLCPCs) to function effectively. Hence, training modules were developed through a consultative process with an aim to provide essential and incremental inputs that would enable CPCs at various levels to understand their roles and initiate functioning in a more effective manner. The process would involve equipping Master Trainers with the same content as well as facilitation inputs so that they can undertake the CPC Induction trainings. The Primary Target Groups were VLCPCs, BLCPCs and WLCPCs. Details of the CPC inception and roll out is as follows :

- ❖ July 2014- Launching of CPC Guidelines in English.
- ❖ September, 2014- Bengali version of Guidelines published.
- ❖ October, 2014- Dissemination of guidelines at district level initiated.
- ❖ December, 2014- Guidelines uploaded on Departmental website.
- ❖ December, 2014- Meeting of NGOs with SCPS on development of training modules.



- ❖ January, 2015- Workshop with DCPOs on CPCs.
- ❖ January, 2015- Engagement of short term Consultant for development of training modules.
- ❖ February, 2015- Training modules development process initiated.
- ❖ March, 2015- Nodal NGO for each district identified.
- ❖ April, 2015- BLCPC formation initiated in all districts including Alipurduar.
- ❖ June 2015- Meeting chaired by HMoS with all stakeholders for setting timeline for formation of CPCs at all levels.
- ❖ Modified CPC Guidelines notified on 03.08.15.
- ❖ Induction Training Manual (Vol I & II) published in November, 2015.
- ❖ Review meetings on status of formation of CPCs in the districts in December, 2015. Fresh timeline set in these meetings.
- ❖ List of Master Trainers sent by DCPUs finalized in January, 2016.
- ❖ Identification of State Level Resource Persons in January, 2016.
- ❖ Orientation of RPs and MTs in February, 2016.

Presently, 341 CPCs at Block level, 1543 at Ward Level and 38487 Village Level Child Protection Committees have been formed till March, 2017.

The CPCs at Block level are now organizing meetings on a quarterly basis. They are playing an active role in prevention of child marriage and awareness generation on missing children, child labour prevention, unsafe migration and

other child protection issues. In Malda, few Pradhans have introduced child budgeting in their development plan. Some CPCs are collecting data at local level and doing vulnerability mapping. DCPUs have been involving CPCs in observation of Child Rights Day, Girl Child Day and the like. In Murshidabad, CPCs have taken an initiative in listing of HIV+ children. Based on their findings, services will be developed for these children. District Magistrates of Malda and Paschim Medinipur are addressing child protection issues in meetings. The need for CPCs is being highlighted in the development meeting of panchayats. In Birbhum, CHILDLINE has been requested to inform local CPC after rescue or restoration so that they can follow up.

In order to roll out the induction training, a pool of State Level Resource Persons including officers of the Directorate of Child Rights and Trafficking, SCPS staff and NGO partners were identified and given an orientation. These Resource Persons undertook training of Master Trainers (MTs). Each district selected 20 MTs from CDPO, ICDS Supervisors, DCPU staff, Protection Officers (under PWDV Act, 2006) and NGO functionaries.

Main objectives of the training of MTs

- ❖ Orientation of Master Trainers about their role in strengthening CPCs.
- ❖ Equipping them with information on key content areas so that they, in turn, help CPCs initiate functioning as mandated under ICPS.
- ❖ Ensuring that they can help CPCs familiarize themselves with key formats/ records and other procedural aspects.
- ❖ Internalizing and aid CPCs in understanding the importance of collaboration between key child protection actors including referral mechanisms.

- ❖ Providing inputs that will promote their facilitation skills in undertaking CPC training.

The MT Training is to be executed in two phases i.e. phase-I & phase-II. Presently phase-I has been carried out. Throughout the year a number of Master Trainers' training were carried out.

- ❖ Reflections on Childhood and Children.
- ❖ Children as Rights Holders.
- ❖ Understanding Vulnerable Children.
- ❖ Safeguarding Children: Child Protection Framework in India.

Child Tracking System

TrackCHILD 2.0 is a mechanism for tracking 'missing' and 'found' children. The National Informatics Centre (NIC) has developed a national portal of Track CHILD which has data on 'missing' children and a live database to monitor the progress of the 'found' children who are availing various services in different Child Care Institutions (CCIs) under the ICPS and the JJ Act. After a successful pilot implementation in West Bengal, the system was rolled out nationally during 2011-12. The portal 'Track CHILD' holds live database of 'missing' & 'found' children and tracks the overall progress of the children living in the Child Care Institutions (CCIs).

If any child is missing or found and report of the child has been filed at the Police Station/Child Welfare Committee/Child Care Institution/ CHILDLINE, then the facts pertaining to that case are uploaded on the portal www.trackthemissingchild.gov.in and the same can be viewed by all concerned family members/CWCs/CCIs/police stations throughout India. So, in case the child is lost in any of the place in India, then the child can be easily traced through the missing child portal.

Genesis

- ❖ TrackCHILD portal has been designed and developed adhering to the guidelines provided in the Juvenile Justice (Care and Protection of Children) Act, 2000 and Model Rules 2007 and the provisions laid down in the Integrated Child Protection Scheme (ICPS).
- ❖ One of the tasks entrusted under ICPS to the State Governments is the setting up of a child tracking system which will facilitate data entry and matching of missing and

found children, enabling follow up of the progress of children who are beneficiaries of the Scheme. Thus, proper monitoring and welfare of the children under the Scheme would also be ensured through the portal. The Child Care Institutes, Child Welfare Committees are being equipped with computers; staff etc. to facilitate data entry of the children under ICPS.

- ❖ TrackCHILD portal provides an integrated virtual space for all stakeholders & ICPS functionaries which includes Central Project Support Unit (CPSU), State Child Protection Society (SCPS) and District Child Protection Units (DCPU), Child Care Institutions (CCIs), Police Stations, Child Welfare Committees (CWCs), Juvenile Justice Boards (JJBs), etc. in the State. It also provides a networking system amongst all the stakeholders and citizens to facilitate tracking of a "Child in distress".
- ❖ It requires data entry and updating at various levels such as Police stations, Child Care Institutions (CCIs)/Homes, Shelters, Child Welfare Committees, and Juvenile Justice Boards etc.

Objectives of TrackCHILD2.0

- ❖ To ensure timely tracking of missing children.
- ❖ To ensure ultimate repatriation and rehabilitation of the missing children.
- ❖ To ensure monitoring of the children in the Child Care Institutions (CCIs).
- ❖ To set up a framework for participating organizations involved in the process.



Features of TrackCHILD2.0

- ❖ Maintenance of e-file for every missing and found children.
- ❖ Maintenance and monitoring of 'Individual Child Care Plan' for every CCI child.
- ❖ Tracking of CCI child.
- ❖ Online matches of 'Found' children with 'Missing' children.
- ❖ Online Report for “Missing/Found” cases.
- ❖ Receiving “e-Alerts” from Citizens or Stakeholders & sending Alerts to other Stakeholders.

- ❖ Search of a “Missing & Found” Child.
- ❖ Online MIS.
- ❖ Automated Search Agent for enhanced searching.

A series of capacity building programmes across the state have been organized to train **Child Welfare Police Officers, District Child Protection functionaries, and data entry operators** on Track CHILD 2.0 throughout the year, in a phase-wise mode for all the districts. One-day orientation programme on the software of quarterly progress report (QPR) has also been provided to the districts in a phased manner.

Darjeeling

District child Protection Unit, Darjeeling is primary responsible for the Care and Protection of Children involving Children in Need of Care and Protection and Children in Conflict with Law. However, DCPU also receives various cases of children that require immediate medical attention. DCPU uses different approaches to cater the needs of children that require medical aid.

Some of the good practices of DCPU for providing medical aid are as follows :

1. Mobilization of Financial Support for the Medical treatment

DCPU coordinates with different Stake Holders/ Philanthropic organizations for providing financial support for the medical treatment of children. In one such cases, DCPU conducted enquiry and then contacted Round Table Siliguri for financial support. They agreed to extend the support to the persons.

2. Liaisons with health departments and hospitals for better treatment in the government set ups.

Many a times the children from far flung places do not get the best medical facilities provided by the government which are mostly available in the cities or urban areas. The poor family can hardly afford the facilities from the BPHCS or up to the sub divisional hospitals. For them, taking the patients to the District Hospital or to Medical Colleges & Hospital of the region is additional burden not only in the part of finance but also in terms of travelling, accommodation, language barrier and others. Hence the family most of the times are reluctant and hopeless to seek better medical treatment in other big cities. In such cases, DCPU coordinates with the health departments and their authorities and closely monitors with the help of Child line partners to provide accessibility to the health centres. DCPU also helps in linking different beneficiaries with existing government schemes for health.



Dakshin Dinajpur

District Child Protection Unit, Dakshin Dinajpur organized Two Phase - I Induction Training for Block Level Master Trainers of Block Level Child Protection Committees (BLCPCs) – one for Four (4) Blocks of Balurghat Sub – division and another for Four (4) Blocks of Gangarampur sub – division on 20th & 21st December, 2016 & 28th & 29th December, 2016 respectively with august presence of District officials and eminent dignitaries.

The training was conducted according the Induction Training Manual for CPCs published

by Department of Child Development, Women Development and Social Welfare. District Level Master Trainers for CPCs conducted the sessions which includes: Safeguarding Children-Child Protection Framework in India, Understanding vulnerable children, CPC: Understanding their roles, Understanding status of the children etc. The participants interacted with their opinion and shared their experiences. Group Discussions and Group Presentations were there regarding CPC intervention in different Case Studies given in the Training Manual.

Julekha felicitated by WBCPCR

had tried to get her marriage but she was reluctant to get married and expressed her view to continue her study. Her family members tortured her badly and she was on starvation for few days. After that she communicated with the Head Teacher, Singar High School (HS), Nabagram, Murshidabad. School authority informed the matter to the Block Level Child Protection Committee (BLCPC) of Nabagram Block. Block Administration prevented her marriage with the help of Local Police and District Child Protection Unit. The Head Teacher provided a shelter in the school and arranged to continue her study. After completion of Madhyamik Examination the Head Teacher communicated with DCPO, Murshidabad for her safe custody since her parents refused to accept her at home. In this circumstance DCPO asked to submit a prayer before CWC, Murshidabad for her safe custody. As per order of CWC the child has been staying at Shilayan Home for girls, Berhampore, Murshidabad. She has been awarded by District Child Protection Unit and West Bengal Commission for Protection of Child Rights (WBCPCR) for her bravery. Now she wants to continue her study from Govt. Run Home.

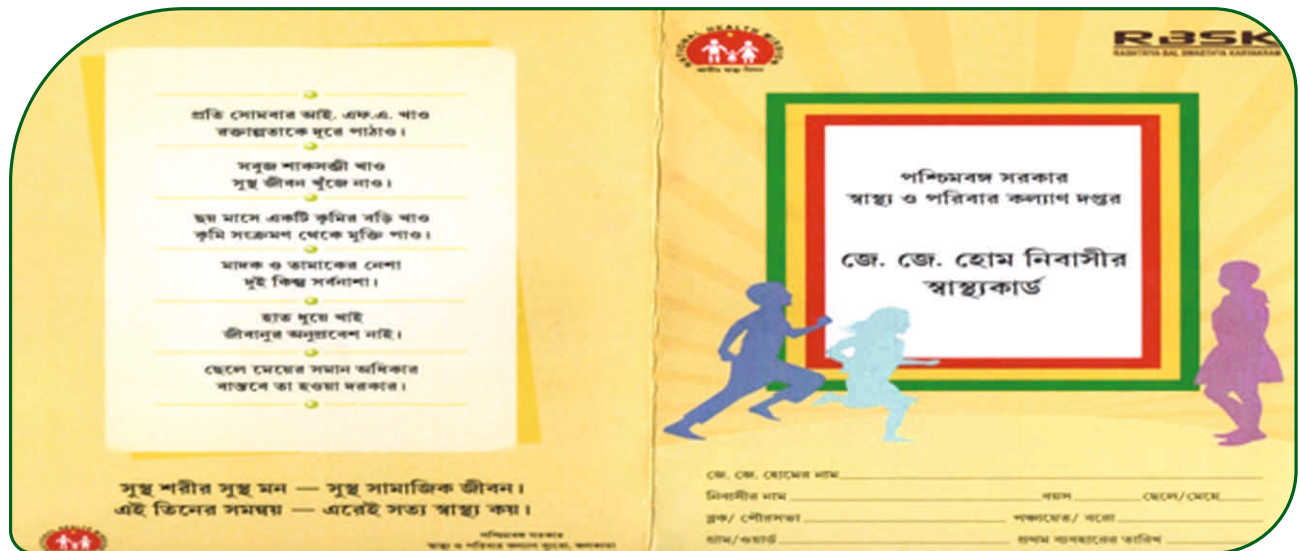


Kolkata

Paschim Medinipur

The District Child Protection Unit of Paschim Medinipur has conducted many activities during the financial year 2016-2017. The unit have actively participated in conducting monitoring visits, outreach activities, capacity building programmes, facilitating in restoration of children, coordination meetings that depicts a remarkable achievement. However, the unit has made an effort to prevent child marriage and help the victims retrieve into normal life. The following case study elucidates the work of DCPU in prevention of Child marriage.

A Child Marriage was prevented in presence of the Secretary of DLSA, Chairperson of CWC,

DCPO, PO(NIC), BWO and Police of Paschim Medinipur at Taldanga, Vidyasagar University under Kotwali Police Station on 16.03.2017. In this particular case the groom was of minor age that is below eighteen years while the bride was an adult. It was a matter of love affair and they got married in a temple in absence of temple priest. No sooner, the case came into the notice of district officials, the district officials intruded into the matter and tried to explain the legal complications and consequences of under-age marriage. Finally, the bride agreed to continue with her studies and the groom promised not to meet the girl before attending 21 years of age. The officers successfully prevented them from the evils of child marriage.



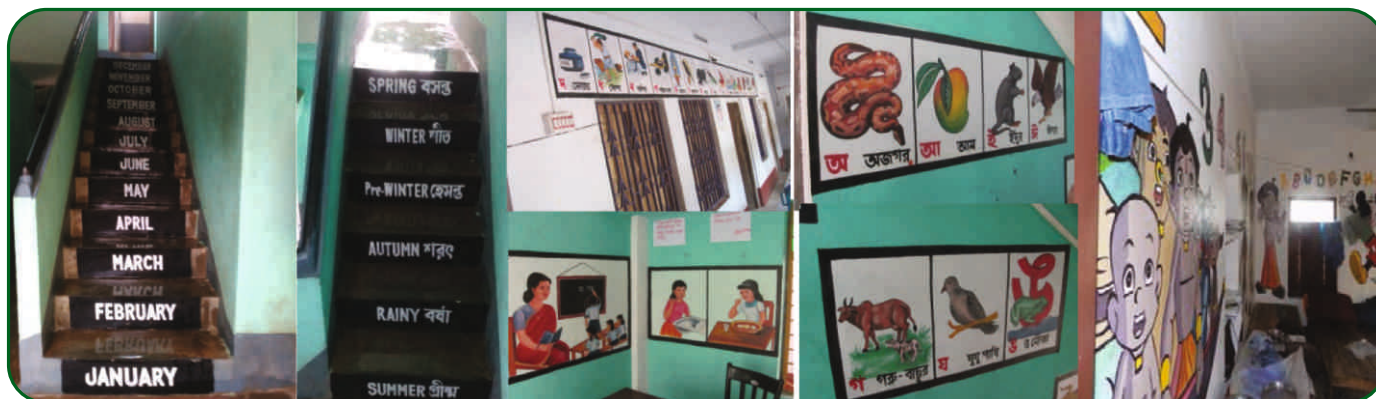
