Considering the formation of three new districts in the State of West Bengal and in cancellation of previous notification and circular in connection with "place of Safety", the Governor is hereby pleased to notify the following Homes under this Department as "PLACE OF SAFETY" for receiving Child in Conflict with law or to receive the person above the age of eighteen years till attaining the age of twenty one years, who accused of or convicted for committing a heinous offence as defined in the Juvenile Justice (Care of Protection of Children) Act, 2015 between their age of sixteen to eighteen years.

The Governor is further pleased to designate the below noted Homes to act as Place of Safety for the district mentioned against each of the Homes, in addition to their existing set ups in pursuance to Section 49 of Juvenile Justice (Care of Protection of Children) Act, 2015
