Whereas to meet the challenges of protection of rights of Children and also to meet the needs of Children in respect to their proper development and with the objective of strengthening service delivery mechanisms and programmes towards this end, a new scheme namely Integrated Child Protection Scheme has been launched by Government of India in partnership with all State Governments.

AND WHEREAS it is the mandate of the Scheme to constitute a State level Society, Executive Committee and District level Committees.

NOW THEREFORE after careful consideration and notwithstanding anything contained anywhere in any direction to the contrary, the Governor is pleased to direct the formation of following three structures:

- i) State Child Protection Society/Governing Body
- ii) Executive Committee
- iii) District Child Protection Society

It is also ordered to form the State level Society on the Integrated Child Protection Scheme as the State Child Protection Society, West Bengal
