Notice for selection of Chairperson Child Welfare Committee

Applications are invited from eligible candidates for serving Chairperson of Child welfare Committee, constituted under Juvenile Justice (Care & protection of Children) Act, 2015 and Juvenile Justice (Care and Protection of Children) Model Rule 2016 in the following district of the state of West Bengal. Those who satisfy all eligibility criterion as on date 01.11.2022 will also be allowed to participate in the interview.

Important Information

1. **Name of the position** : Chairperson, Child welfare Committee,
2. **No of Vacancies** : 1(one) for the post of Chairperson, CWC
3. **Allowances** : The Chairperson of the committee shall be paid such seating allowance, travel allowance and any other allowance as the state Govt. may prescribe but not less than Rs 2000/- per seating.
4. **Age (as on 01.01.2022)** : Shall be above age of 35 years and not more than 65 years
5. **Essential qualification** : The Chairperson shall have a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children and has been actively involved in health, education or welfare activities pertaining to children for seven years or is a practicing professional with a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children.

6. Other Conditions :

- A. The person applying for the post of Chairperson of the Committee shall submit an affidavit as per form 49 (as attached in annexure I), certifying that the applicant is not barred by any of the conditions laid down in sub section 4(A) of section 27 of the Act (as mentioned below). The appropriate government authority shall then verify the same as per norms.
- B. A person associated with an organisation receiving foreign contribution shall not be eligible to be a Chairperson or member of the Committee.
- C. Any person working in the implementation of the Act in any Non-Government Organisation or any organisation, performing such functions which may cause conflict of interest (within the meaning of rule 4A of Juvenile Justice (Care and Protection of Children) Central Model Rule 2016 as amended by Juvenile Justice (Care and Protection of Children) Model Amendment Rules, 2022) in discharge of their duties as the Chairperson or Member of the Committee shall not be eligible for appointment as the Chairperson or Member of the Committee.

7. A member selected by the Selection Committee should not:

1. Be holding such full-time occupation that may not allow the person to give necessary time and attention to the work of the Board or the Committee.
 2. Be associated with any Child Care Institution, directly or indirectly, during his tenure as a member of the Board or Committee or have any other conflict of interest.
 3. Hold an any office in any political party during his/ her tenure, or
 4. Be insolvent.
8. Chairperson or Member of the committee shall be eligible for appointment to the position of Chairperson or Member and vice-versa for maximum of 2 terms irrespective of place(s) where they served.

9. All the qualification and experience must be completed on or before 01.11.2022

Scope of work: The Committee shall sit on all working days for a minimum of six hours commensurate with the working of a Magistrate Court, and for at least 20 days in a month.

The willing candidates may apply in the prescribed application format through **ONLINE Portal only**, in the website <http://wbcdwds.gov.in> from 22-11-2022. **In any case application will not be received by hand or by post or through email.**

Last Date for submission of application: 6 PM of 21-12-2022. The portal will be closed at **6 PM of 21-12-2022.**

The decision of the selection Committee regarding all matters relating to the selection process shall be final.

- (i) I do not have any past record of violation of human rights or child rights,
- (ii) I have not been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence,
- (iii) I have not been removed or dismissed from service of the Government of India or State Government or an undertaking or corporation owned or controlled by the Government of India or State Government,
- (iv) I have never indulged in child abuse or employment of child labour or immoral act or any other violation of human rights or immoral acts, or
- (v) I am not part of management of a child care institution in a District;

2. If found otherwise by the State Government, I shall be liable for punitive action.
