Notice for selection of Social Worker Member Juvenile Justice Board

Applications are invited from eligible candidates for serving as **Social Worker Members of Juvenile Justice Board**, constituted under Juvenile Justice (Care & protection of Children) Act, 2015 and Juvenile Justice (Care and Protection of Children) Model Rule 2016 in the following district of the state of West Bengal. Those who satisfy all eligibility criterion as on date 01.11.2022 will also be allowed to participate in the interview.

Important Information

1. **Name of the position** : Member, Child welfare Committee,
2. **No of Vacancies** : 2(Two) for the post of Social Worker Member, Juvenile Justice Board
3. **Allowances** : The Member of the Board shall be paid such seating allowance, travel allowance and any other allowance as the state Govt. may prescribe but not less than Rs 2000/- per seating.
4. **Age (as on 01.01.2022)** : Shall be above age of 35 years and not more than 65 years
5. **Essential qualification** : The Member shall have a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children and has been actively involved in health, education or welfare activities pertaining to children for seven years or is a practicing professional with a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children.

6. Other Conditions:

- A. The person applying for the post of Social Worker Member of the Juvenile Justice Board shall submit an affidavit as per form 49 (as attached in annexure I), certifying that the applicant is not barred by any of the conditions laid down in sub section 4(A) of section 27 of the Act (as mentioned below). The appropriate government authority shall then verify the same as per norms.
- B. A person associated with an organisation receiving foreign contribution shall not be eligible to be a Social Worker Member of Juvenile Justice Board.
- C. Any person working in the implementation of the Act in any Non-Government Organisation or any organisation, performing such functions which may cause conflict of interest (within the meaning of rule 4A of Juvenile Justice (Care and Protection of Children) Central Model Rule 2016 as amended by Juvenile Justice (Care and Protection of Children) Model Amendment Rules, 2022) in discharge of their duties as the Chairperson or Member of the Committee shall not be eligible for appointment as the Chairperson or Member of the Committee.

7. A Member selected by the Selection Committee should not:

1. Beholding such full-time occupation that may not allow the person to give necessary time and attention to the work of the Board or the Committee.
 2. Be associated with any Child Care Institution, directly or indirectly, during his tenure as a member of the Board or Committee or have any other conflict of interest.
 3. Hold an any office in any political party during his/ her tenure, or
 4. Be insolvent.
8. Social Worker Member of Juvenile Justice Board shall be eligible for appointment to the same position for maximum of 2 terms irrespective of place(s) where they served.

9. All the qualification and experience must be completed on or before 01.11.2022

Scope of work: The Committee shall sit on all working days for a minimum of six hours commensurate with the working of a Magistrate Court, and for at least 20 days in a month.

The willing candidates may apply in the prescribed application format through **ONLINE Portal only**, in the website <http://wbcdwds.gov.in> from **22-11-2022**. **In any case application will not be received by hand or by post or through email.**

Last Date for submission of application: 6 PM of 21-12-2022. The portal will be closed at **6 PM of 21-12-2022.**

The decision of the selection Committee regarding all matters relating to the selection process shall be final.
